

Introduction to Open Educational Resources

OER stands for Open Educational Resources. OERs are teaching and learning materials provided openly and without cost to students; OERs can be open textbooks, courses, learning modules, digital learning objects, open-access journals, streaming videos, and more.

OER - An Overview

Below is a more detailed account of the history of OER, its use in education, and its benefits for students and faculty.

Background

The open-source software community initially inspired the open education movement, focusing on broadening access to information through free, open content. OER has always been a grassroots initiative, with many individuals and organizations contributing to its development. One of the first major initiatives was MIT's OpenCourseWare Imitative, founded in 2001. As Bliss & Smith (2017) explain in their breakdown of the history of open education:

Much of our attention focused on OER's usefulness at providing knowledge in its original form to those who otherwise might not have access. The implicit goal was to equalize access to disadvantaged and advantaged peoples of the world – in MIT's language, to create 'a shared intellectual Common(Bliss & Smith, 2017). ¹

However, OER is not an exclusively North American movement. For example, significant growth occurred after the <u>UNESCO Forum on the Impact of Open Courseware for Higher Education in Developing Countries</u> convened in 2002. In part, the final declaration at the forum stated that participants "expressed their... wish to develop together a universal educational resource available for the whole of humanity, to be referred to henceforth as Open Educational Resources" (UNESCO, 2002, p.6.).²

Following the rise of open education in the early 2000s, growing interest in open courseware (particularly open textbooks) catapulted the movement to new heights; however, the movement toward greater OER awareness among instructors is growing slowly and steadily. A survey done in the U.S. in 2018 indicated that 47% of instructors had never heard of OER, while the remaining instructors had some degree of familiarity with the concept. There is still a large number of instructors who are unaware of OER, but the percentage has shrunk by 19% since 2014, showing that awareness is growing (Seaman & Seaman, 2019). Defining OER

The Hewlett Foundation provides the most comprehensive definition of OER available today:

Open Educational Resources are teaching, learning and research materials in any medium – digital or otherwise – that reside in the public domain or have been released under an open license that permits no-cost access, use, adaptation and redistribution by others with no or limited restrictions (Hewlett Foundation, n.d.).

So, Open Educational Resources (OER) are openly licensed, freely and easily accessible educational materials that users can adapt and redistribute. While many think of OER as referring predominantly to open textbooks, OER includes a wide variety of resources, such as videos, images, lesson plans, coding and software, and even entire courses.

The 5R's of OER

For a resource to be considered open, it must fulfill the following criteria called the 5Rs:

- Reuse take a resource and use it in any context that you want
- Remix take multiple resources and mix them to create a new resource
- Revise take a copy of a resource, change it and adapt it to the local context 5
- Retain take a copy and have control of that copy forever
- · Redistribute the right to share what you have created
- 1. 2. 3. ⁴
- 4. The resource must explicitly state that it is available for remixing and redistribution by others. Some open licences may include restrictions on how others may use the resource. You can read about this more in the Copyright & Licensing chapter
- 6. Although all OER are openly licensed, many are released in formats that do not easily allow for adaptation.

With a broad definition that includes any educational material so long as it is free to access and open, it might be easier to ask, "What isn't an OER?

What is Not an OER?

If a resource has a traditional copyright licence or requires a fee to be accessed, it is not considered an OER. For example, most materials accessed through the library's subscriptions cannot be altered, remixed, or redistributed. Therefore, these materials require special permission and are not "open." Similarly, YouTube's standard license includes a traditional copyright statement that does not allow videos to be retained (saved), altered, or remixed.

Benefits for Students

Cost Savings

One of the often cited benefits of OER is the cost savings for students. Alongside tuition fee increases at Canadian institutions of about 3% yearly, compulsory fees can set students back nearly \$1,000 a year and are often not covered by student loans. According to Statistics Canada, the average Canadian undergraduate student paid approximately \$1,091 in compulsory fees during the 2023/2024 school year. (Statistics Canada, 2023). This price was up 4.5% from the previous school year.

The cost of textbooks impacts college students, who must wait to purchase their course materials until well into the semester or choose not to purchase them (Florida Virtual Campus, 2018). A 2018 survey of SAIT students found that over 90% of respondents were very concerned about textbook costs (Southern Alberta Institute of Technology, 2018). In 2019, 25% of SAIT students reported never or rarely purchasing textbooks for their course, citing the cost (Southern Alberta Institute of Technology, 2019). The cost of textbooks might not be a significant issue, but it can be an insurmountable hurdle for students struggling to get by. A recent study at the University of Manitoba indicated that 35.3% of students experienced some degree of food insecurity throughout their degree (Entz et al., 2017).

Access to a Quality Education

When you share course materials openly, you allow students to engage with your content before, during, and after your course. Because OER is always free to access online, students interested in taking a course you teach can read up on the course beforehand and ensure they are ready and interested in the material. Moreover, students who have already taken your course can rely on the fact that their course materials will not evaporate at the end of the semester and that they can continue to review the materials you provided for years. With increased inclusive access models from publishers, temporary access to educational materials is becoming more common. This type of access may reduce the entry cost for students to access a textbook for one semester, but this access is typically limited and comes with other hidden costs.

The students who benefit from access to OER are not just the ones in your classroom. OER is free for anyone worldwide to access, whether they have a university affiliation or not. ⁷ This encourages learners and students

to explore educational content without committing the time and money they might not have to attend postsecondary.

Benefits for Faculty

Although cost savings are a major talking point in favour of open educational resources, instructors can integrate OER into their courses without removing the paid resources they find helpful (SUNY OER Services. (n.d.).). While creating an entire OER textbook can seem daunting, the gradual integration of small OER as supplementary resources can be built up over time. Over a few years, instructors may find that they have tailored so many small OERs to their course content that these resources are more effective in supplementing the course than the paid resources they previously used. The freedom to adapt OER to instructional needs is often the most attractive aspect of OER. Since OERs are openly licensed, educators can edit, reorder, and remix OER materials in various ways.

Use, Improve, and Share

Many instructors report using their required course textbooks in different orders than suggested or skipping entire portions of the textbook altogether (Liebermen, 2019). Using OER allows instructors to adapt and revise existing versions of openly licensed books to fit their course material better. Supplementary resources may be added directly to the text, streamlining resource access for students and giving a clear course outline that aligns with the syllabus. Instructors may also update an existing OER to provide modern and culturally relevant examples.

Network and Collaborate with Peers

A significant concern with open resources is that they may be seen as less reliable than traditionally published materials that go through rigorous editing processes. However, opening up resources makes it easier for peers across institutions to review and edit each other's work. The ability for others to edit and re-share work also allows you to explore the reviews and gain a deeper understanding of the available resources. Not to mention, creating open resources is a great chance to build a team of peers to help develop a new and valuable learning tool.

Lower Costs to Improve Access to Information

One of the most popular reasons for creating and reusing OER is that it allows every student easy access to course resources. This, in turn, benefits instructors, for all of their students will have all the tools needed to succeed in the course, regardless of financial or accessibility barriers. Open course resources may also lead to more passionate and engaged students, as students can explore course material before enrolling.

There are two options: finding existing OERs and creating your own

Finding Existing OER Steps

- Step 1: Connect: Contact the OER Design Studio to chat about options.
- Step 2: Learn: Complete our OER Prep course and learn about OER and open licensing.
- Step 3: Scan: Work with the library to create an environmental scan of OER for your course.
- Step 4: Evaluate: Check the scan. Are there resources that meet most of your needs?

If your answer is "Yes" then you can adopt the existing resource(s).

If no OER exists that meets your needs, then you can create your own.

Creating Your Own OER Steps

- **Step 5:** Define: Outline the scope, structure and style of your new resource.
- **Step 6:** Develop: Work with the studio to build your content.
- Step 7: Review: Engage your colleagues, students and other users in reviewing your new resources.



Connect and Learn

To support the environmental scan process, it may be helpful to learn more about OERs and open licensing. The <u>OER Prep Course</u> contains self-paced learning modules designed to provide an introduction to open educational resources (OER) and open licensing.

Throughout the modules, there are opportunities to check understanding and explore concepts further. The modules can be followed in any order, but it is recommended to start with **Module 1** and progress through in order. The final product is the course map (environmental scan).

You will meet with your instructional designer **weekly** to communicate any changes or updates on the project. All meetings are conducted virtually through Zoom.

Schedule

- · Chapter content is due to the instructional designer on **Fridays.**
- For fall and winter developments, 1 chapter is due each week, and for summer developments, two chapters per week.
- The Studio takes an agile approach to development, focusing on one chapter or module at a time and incorporating any feedback into future modules/chapters.

A Note About Publishing

Note

If publishing is new to you, here are some things to keep in mind:

- · There are lots of ways to publish. You can decide what's possible.
- · You can always change how you do something for the next project or iteration.
- · Making a book is a creative endeavour and, therefore, may involve a lot of subjective decisions.
- · Try to seek collaborators who can work with uncertainty, especially initially.
- · Take a break when you need to.
- · Don't try to accomplish all your goals the first time around.
- · Go easy on yourself, especially if you're new at this!
- · Ask others for help.



In the OER Design Studio, we use <u>Pressbooks</u> for creating and publishing OER resources. In the development phase of your project, you'll become more familiar with Pressbooks and how it works.

Project Type

The type of OER project you will engage in will become clear after reviewing the list of existing open resources (*OER Course Map*) and identifying the gaps or lack of alignment with your teaching practice.

Two types of OER projects are an adaptation and a collection. An **adaptation** also called a derivative, mixes or remixes a copyrighted work to create a new original copyrighted work. A **collection** is the assembly of separate and independent works into a collective whole. These two types are discussed more below.

Adaptation

The term **adaptation** is commonly used to describe the process of making changes to an existing work. We can also replace "adapt" with revise, modify, alter, customize, or other synonym that describes the act of making a change. This concept can be illustrated with a smoothie. Individual fruits are blended together and result in a new creation. The individual ingredients are no longer distinguishable. Nevertheless, attribution for the individual works is still required.

Some Creative Commons licenses allow others to make adaptations or remixes. It's important to understand what an adaptation is and to review the licensing of materials before deciding to <u>adapt (see next section)</u>. *The Creative Commons FAQs provide examples and explanations.*

Using information and media from an open textbook or other open educational resource is NOT considered plagiarism.



Examples of adaptations include:

- · a screenplay based on a novel
- · a book translated from one language to another
- · a chapter in an open textbook that blends multiple open educational resources.

The new work must be derived from the copyrighted work.

Adapting open resources can be a good place to start, and there are many reasons why you would revise existing work:

Reasons for Adaptation

- · Address a particular teaching style or learning style
- · Adjust for a course level.
- · Customise for your curriculum
- · Adapt for a different discipline.
- · Address diversity needs.
- · Customize for a Canadian audience, or perhaps for students in Ontario.
- · Make the material more accessible for people with disabilities
- · Add material contributed by students or material suggested by students
- · Translate the material into another language
- · Correct errors or inaccuracies
- · Update the book with current information
- · Add more media or links to other resources
- · Use only a portion of the book for a course

Collection

A **collection** is the assembly of separate and independent works into a collective whole. Each work in a collection retains its copyright protection and licensing terms. Each individual work in a collection must have attribution and licensing information.

While an adaptation can be compared to a smoothie, a collection is more like a fruit salad. Each work — the strawberries, blackberries, apples, etc. — is part of the collection which is the fruit salad.



While a separate copyright exists for the collection, it only applies to the new contributions to the work such as the cover, the introduction, and the actual arrangement of the selected works (think about the fruit choices you might make for a fruit salad to create your own unique combination of flavors).

Examples of collections include:

- anthologies of writings by various authors; encyclopedia;
- · a coffee table book featuring photographs by various photographers; and,
- · an album compilation of '80s pop hits.

As with adaptations, the licensing of a collection must be compatible with the copyrights and licenses of the individual works. The license for the collection does not alter the licenses for the works in the collection. For more information, consult the <u>Creative Commons FAQs</u>

Adaptation Considerations

When it comes to working with OER, one of the conceptual hurdles faced by most people is the notion of adapting or changing someone's work. What exactly can be adapted within the scope of an open textbook? Won't the original author get upset if you change their work?

Changing someone's work can feel uncomfortable. But rest assured, if the author has released their textbook under a Creative Commons license that allows for adaptation (which is any Creative Commons license that does not have a No Derivative (ND) attribute added to it) then they expect that you will change the content, providing you give them the proper attribution (and we'll get into this). Using information and media from an open textbook or other open educational resource is NOT considered plagiarism.



What Can You Change?



Anything and everything in an open textbook can be changed as long as the conditions of the open license are met. The modifications or changes you make can be fairly minor or major depending on what you need to do to make the book work for you. That is the beauty and power of open textbooks. You are in charge of the resource. You have been given permission to change it ahead of time by the original author.

Compatible Licenses

Keep in mind that when you are mixing different resources you need to be cognizant of the licenses as some of the Creative Commons licenses are incompatible. See this graphic below for more information.

- · Also, note that a license with a No Derivative (ND) attribute means you are not able to change the contents.
- · See <u>Creative Commons</u> for more information on licenses.

When the adaptation includes more than one CC-licensed work, the licensing compatibility also must be observed before a creator can choose a license for her own contribution (the "adapter's license). The chart below describes which CC licenses can be chosen as an adapter's license. The licenses in green are fully compatible, while the ones in grey are not. Choosing a license corresponding to the yellow boxes is not recommended, though technically allowed by the terms of the license.

Recording Your Changes

As the author, you retain the copyright of all new material you create. This means that even if the new material you create is released under an open license, as the author, you will receive attribution for your contribution. As you edit and make changes (text and images) and/or add new material, such as a chapter or section within a chapter, keep a list of the additions/changes. This information can be included in the front matter of the book under the acknowledgments or copyright information. Minor changes, such as fixing grammatical or spelling mistakes, don't need to be documented. If you add material from another openly licensed work to your adaptation, especially text, record the source and where it is used in your adapted version. This information is needed for the wording and placement of each attribution statement required for each open CC BY (Creative Commons Attribution) licensed work you use. For more information, see Attribution Statements or the OER Prep Course.

Project Scope - Development Plan



Before beginning any new OER development project, you must have a completed environmental scan (OER Course Map). The OER Course map identifies any existing OER materials that can be repurposed. You can begin to populate some of the resources you will reuse or re-mix in the OER Development Plan.

Development Plan Purpose

Defining your project is essential because it helps you understand what you're working towards, but also because it helps provide information about the project to the team you are working with. The OER Development Plan provides a road map for the project and may evolve over time. It is meant to help identify the following:

- · How many chapters are there, and what topic are the chapters on? Learn more in the section on **Book Structure.**
- · What are the learning outcomes for each chapter?
- · Do the learning outcomes align with your course-level outcomes and assessments?
- · How will your content be organized?
- What OER material currently exists that can be repurposed (OER Course Map)
- · Are there any gaps?

The development plan should provide the overall proposed structure of your new book. We will use a <u>backward design approach</u> starting with the learning objectives/ outcomes.

The learning outcomes MUST be measurable. See Appendix 1: Learning Objectives <u>Guide</u> for sample verbs requiring cognitive outcomes.

Start Small Think BIG

The OER writing process can be time-consuming and difficult. Scope creep can be common. To prevent you from falling into this trap, consider starting small. If you are adapting a book consider the types of changes you can make:

Small Changes

- · Changing titles of the book or chapters.
- · Adding new images.
- · Removing a chapter that isn't pertinent to your course.
- · Chapters might be reordered to more accurately fit the order in which material is presented in a course.
- · Add examples of content written by your students.
- · Adding context to your discipline.

Big Changes

- · A significant number of chapters might be removed, changed or added.
- Re-writing the book from an equity lens. Adding in different perspectives.
- New material is written to fill in the gaps of an existing textbook.
- · Resources added, such as new examples or exercises.
- · Creating ancillary resources for a book.

Considerations

If you are starting from scratch, consider the following:

- · Think about your audience. Students do not enjoy reading long chapters. Keep things concise and focus on the key concepts and takeaways.
- · Add in links for those students who may want to delve deeper into the subject.
- · Engage your students in co-creation activities as part of their assessment.
- · Remember you can always build on to the resource at any time!

Think of the huge pedagogical potential hidden away in an open textbook. Plan and dream and scheme about what could be done with this book. When you're bursting at the seams with ideas and enthusiasm, write down all of the wonderful things you want to change, when both you and the textbook are ready, on your Bucket List - Scope Document.

Five Rules of Textbook Development

The below list provides five rules that help guide the development of a good textbook.

1. Rule of Frameworks

Memory and understanding are promoted by using a structure that mimics the structures we use to store information. Before we can use or master a subject, we must have a mental road map to navigate the subject domain. The text can best aid understanding by making this framework visible within each section.



This can be achieved by establishing a consistent organizational structure, format, and design elements. See Design & Structure Considerations.

2. Rule of Meaningful Names

Everything we know is tagged with an index or a title, which allows us to recall what we know and remember. Each concept, process, technique, or fact presented should aid the student in assigning a meaningful name for their mental organization of the material. The names assigned by the text should help support future activities: communication with other practitioners, reference within the text to earlier mastered material, and conformity to the framework used for the subject.



Use consistent titles and terminologies. Use terminology that is common in your discipline. This can be achieved by including glossary/key term pages, planning your content structure, and reviewing for consistency. See Key Terms & Glossary

3. Rule of Manageable Numbers

When we learn from an outline, an illustration, or an example, most of us are limited in our ability to absorb new material. This number expands as we become familiar with part of a subject domain, but four to six new elements for new material is a reasonable limit. If a chapter outline contains twelve items, the student will have forgotten the outline before getting to the last item. When a text fails to support this rule, a diligent student must repeat the material needlessly.



Limit the amount of information introduced at one time. This can be achieved by breaking chapters into smaller sections, focusing on learning objectives at a higher concept level and planning your content structure. See Appendix 1: Learning Objectives Guide for more details.

4. Rule of Hierarchy

Our mental frameworks are hierarchical. Learning is aided by the student's ability to couple or link new material with that already mastered. When presenting new domains for hierarchical understanding, the rules for *meaningful names* and *manageable numbers* have increased importance and more limited application. A maximum of three levels of hierarchy should be presented at one time. The root should be mastered, the current element under consideration examined, and lower levels outlined only to the extent that they help the student understand the scope or importance of the current element. Two more rules within this rule supplement this area: Connectivity and Cohesion. **Connectivity** requires consideration of what the student likely knows at this point. **Cohesion** requires that the characteristics of new elements as they are presented be tightly coupled.



The text should build on learned knowledge. When introducing new material, only refer to foundational material if it is relevant to the new material. The student must understand the foundational knowledge before being introduced to a new concept. When new concepts are introduced they should be explicitly connected to the


foundational material.

5. Rule of Repetition

Most people learn by repetition, and only a few with native genius can achieve mastery without it. There is a pattern of repetition that aids in promoting the elements of a subject from short-term to long-term memory. Implementing this rule may mean that frameworks and important hierarchies are repeated as many as five or six times. In comparison, frequently used elements are repeated three or four times, and elements of lesser utility may not be repeated. The first repetition should typically occur within a day of the first presentation, followed by a gradually decreasing frequency. Exercises and review sections ideally contribute to a designed repetition pattern.



Repeat important concepts. Review the content to determine which information should be repeated and how often.



5 Rules of Textbook Development

5 Rules of Textbook Development long description:

- 1. The rule of frameworks means maintaining a consistent structure. The text can best aid understanding by making this framework visible early on.
- 2. The rule of meaningful names means to create and use consistent titles and terminologies. The names are critical to the ability to recall or retrieve the things we know and remember.
- 3. The rule of manageable numbers means limiting the amount of new information introduced at one time.
- 4. The rule of hierarchy means new knowledge builds on learned knowledge. The student needs to understand the foundational knowledge before being introduced to a new concept. When new concepts are introduced they should be explicitly connected to the foundational material.
- 5. The rule of repetition means repeating essential concepts. There is a pattern of repetition that aids in promoting the elements of a subject from short-term to long-term memory.

Diversity, Equity and Inclusion

One of the basic premises of open education is access. The United Nations Educational, Scientific and Cultural Organization (UNESCO) believes:

...that universal access to high quality education is key to the building of peace, sustainable social and economic development, and intercultural dialogue. Open Educational Resources (OER) provide a strategic opportunity to improve the quality of education as well as facilitate policy dialogue, knowledge sharing and capacity building.

Access in this context refers to the ability of students, instructors, and others to obtain access to education. Releasing textbooks and other educational resources with open-copyright licenses is a big step toward removing barriers, as it makes these materials free of cost and free to use, distribute, and change. But there is more that goes into accessing a resource than it is just being free and online. For a textbook to be truly accessible, people of all abilities need to be able to access the content. This means designing a textbook that accommodates people with diverse learning styles and ensuring the content can be accessed by all, regardless of disability. It also means creating materials that include diverse viewpoints and voices. As you plan your textbook, contemplate how to design it so it is accessible, diverse, and inclusive.

Some benefits are:

- · Engaging more students because they recognize themselves or their life experiences in the material
- Appealing to instructors in a variety of educational settings
- · Creating a more interesting reading and learning experience

Diversity

Diversity refers to having a range of people across gender identities, racial backgrounds, geographic locations, socioeconomic backgrounds, ages, abilities, sexual orientation, and other characteristics represented and participating in a community. Diversity has to do with whose perspectives are being heard, who gets to make decisions, who gets to meaningfully engage at all levels of the community, and more.

Equity

There are systemic barriers people face based on their gender identity, race, geographic location, class, age, ability, sexual orientation, and other factors. Equity recognizes that people need a variety of resources and support to overcome these barriers and succeed. Open textbooks designed with an equity mindset reduce barriers and facilitate a deeper engagement with the course material.

Inclusion

Inclusion is about making a resource, location, or event welcoming and inviting so that people from different backgrounds feel that they belong. Inclusive design means that you're creating a lot of different ways for

people to participate in an experience and make a decision.

Embedding equitable and inclusive practices into our work requires an open and curious mindset. It can be helpful to continuously pause and ask ourselves: what are we missing? This can be hard to do, but it's critical to take the time to investigate and include others in the inquiry.

Equitable and Inclusive Practice Content Considerations

Here are some questions for authors, and those supporting authors, to consider throughout the content development process:

- · Whose voices or perspectives are missing?
- · Does this material reflect the students who will use it?
- · Is this resource relevant and reflective of students' lived experiences?
- Does this resource reflect privilege that may be invisible to the author?
- · Who can't access or will struggle to access this material?
- Are we providing clear language about how to use the resource?

Tips

- · Including a variety of pronouns and gender expressions to describe people in your text
- · Using images, examples, and case studies that depict Indigenous, Black, and other people of colour without perpetuating stereotypes
- · Using images, examples, and case studies that depict people with disabilities, and bodies of all sizes, without perpetuating stereotypes
- · Using images, examples, and case studies that depict 2SLGBTQIA+ people without perpetuating stereotypes
- · Including Indigenous territories and place names in addition to, or in lieu of, colonial place names

Accessbility

As an open textbook author it is important to consider how all students will engage with the content. Listed below are some of the barriers students face during their education, as well as some solutions and examples.

Reducing Barriers to Access

Tips for Accessibility

Here are some accessibility tips:

- · Use clear, straightforward *language*. Make the content understandable.
- Provide *multiple formats* whenever possible. This will allow different users to access the resource in different ways.
- · Use a clear organizational structure to guide readers through the resource.
- Provide proper information and resources to make the content readable and *understandable* for users (ie. Glossary, Abbreviation list).
- · Develop an accessibility statement to show ways that the resource has been made more

- accessible and a way for users to contact you with suggestions to improve accessibility.
- When requesting peer reviewers, make sure to highlight the importance of accessibility, diversity, and inclusion.

Universal Design

Universal Design is the process of creating products (devices, environments, systems, and processes) that are usable by people with the widest possible range of abilities, operating within the widest possible range of situations (environments, conditions, and circumstances). Universal Design emerged from the slightly earlier concept of being barrier-free, the broader accessibility movement, and adaptive technology and assistive technology. It also seeks to blend aesthetics into these core considerations.

Copyright

When individuals create open educational resources they are creating educational materials that are intended to be shared broadly with a global audience with minimal restrictions or requirements. Since these educational materials are shared beyond the school's learning management system and with an audience beyond our registered students, the use of copyright-protected content will often require permission for use. Educational exceptions that allow the use of copyright-protected content in the classroom do not necessarily apply to their use within open educational resources.

Copyright Considerations

Consider the following while you are writing or creating new open educational resources:

- Avoid where possible the use of copyright-protected content in your OER. It is acceptable to
 refer to and link to the copyright-protected content if it is publicly accessible online but avoid
 copying or incorporating copyright-protected content in whole or in part within open educational
 resources. Choose to use content that has already been openly licensed or that is available from
 within the public domain (public domain content is content that has been previously protected
 by copyright but that copyright protection has lapsed, expired, or been waived).
- Fair Dealing: If you need to include copyright-protected content within your OER, the possibility to do so may be available within the scope of fair dealing. The fair dealing exception from the Copyright Act does not waive the copyright protections of a work, therefore, materials included under fair dealing need to include a notice that the open license is not applicable to that content. Therefore, you must take care when using fair dealing within open educational resources.
- **Permission:** If you would like to include copyright-protected content within an open educational resource, but your intended use does not fit within the scope of fair dealing, you will need to obtain permission from the copyright owner before the copyright-protected content is included in an open educational resource. This may also apply to adapting other's OERs that include copyright-protected content, as their permissions to use the content may not extend to you, especially if the content is included as an exception to the open licence.

What Copyright Law Allows You to Copy

With these considerations in mind, here are some clear-cut situations where you can use copyright-protected content without needing to obtain the copyright owner's permission, including:

- 1. Your Own Work Copying and distributing your own work is up to you. Please note, however, that permissions may be nonetheless required if (1) the work contains third-party copyright-protected content, or (2) you've transferred your copyright in the work to a third party, as is often the case with published works such as books and articles.
- 2. Insubstantial Portions of Works Copying quantitatively and qualitatively insubstantial amounts of a

- work does not require permission or payment for use in the classroom or course site. Examples of insubstantial use in an open educational resource would be referring to a copyright-protected work or linking out to a publicly accessible online site or source. If quoting more than a few sentences at a time, consider whether the amount copied is substantial and obtain the necessary permissions.
- 3. Material in which Copyright Cannot Exist Copyright does not protect facts and ideas, it only protects an copyright owner's expression and publication of those facts and ideas. The novel 'Harry Potter and the Philosopher's Stone' is protected by copyright. The idea of a child wizard who confronts an evil wizard is not. Similarly, a textbook on geology may be protected by copyright but the facts in it (about sedimentation, magma, tectonic plates, etc.) are not.
- 4. **Material no Longer Protected by Copyright** In Canada, a work's copyright protection typically ends 70 years after the death of its author, regardless of the citizenship of the author or where the work was originally published. When a work's copyright protection ends, the work is said to enter into the public domain. See <u>UBC's Public Domain Guide</u>.
- 5. **Openly Licensed Works** material that has been licensed by a Creative Commons license or other open, free-for-use licences can be used with minimal restrictions. Note, it is important to review the terms of the license that has been applied so as to ensure that you comply with those minimal restrictions.
- 6. Government of Canada Works Government of Canada material may be reproduced for personal or public non-commercial purposes unless there is a specific indication to the contrary attached to the work. Permission is required to reproduce, revise, adapt or translate a work for commercial distribution. Permission is also required to incorporate Government of Canada works and other governments in Canada's works into open educational resources. Materials produced by other governments around the world are subject to similar rules. It is best to include links to government works within open educational resources rather than incorporating government works into open educational resources.
- 7. **Hyperlinks** Providing an Internet link to a work is not generally considered to be the same as making a copy, so it does not trigger the requirement to obtain permission or pay licensing fees.

Getting Started with Pressbooks

Now that you have mapped out your project, it is time to start getting familiar with the tool that will be used to publish your project.

Pressbooks is an open-source, web-based authoring platform. The "Press" portion refers to the fact it is built on the WordPress web content creation platform, and the "Books" portion refers to the intention to use the tool for publishing open online books. Let's look at some of the key features of Pressbooks.

Key Features

- · Write once, publish many: Pressbooks make it easy to export well-formatted publications in multiple outputs (PDF, EPUB, and more)
- WYSIWYG (What You See Is What You Get) Editor for familiar creation: Creating right in Pressbooks is similar to creating a Word document with a bit more fun added to the mix
- · Easily clone other openly licensed content created in Pressbooks to adapt for any teaching and learning context.
- · Accessible: By default, web-based resources built in Pressbooks are designed to be accessible and compatible with screen readers and other assistive technologies. Remember, there are other key elements you need to consider when creating to make your resource more accessible and inclusive.
- Easily add users with various roles and permissions to enable collaboration on a resource.
- · Familiarity with the traditional textbook, but with the ability to move the medium forward and become more of a learning environment

Create an Account


Pressbooks is a centrally managed network of individual books hosted by eCampusOntario and available for free to educators, students and staff at Ontario colleges, universities, and Indigenous institutes. This is Ontario's <u>Pressbooks homebase</u> – and each book you create will have a home page on this network.

Pressbooks Account Activation

If you don't already have an account, there are two pathways to get one. Either way, start by:

- 1. Navigate to the <u>eCampus Ontario Pressbooks login page</u>
- 2. Select "institutional login" and click Fanshawe College from the list.

- 3. You will be directed to Fanshawe's login page. Enter your credentials, and you should be able to access Pressbooks upon completion of authentication.
- 4. Once successfully logged in, you'll be presented with a page like the one you started with, but with "Admin" and "My Books" options (seen in the image below).

If you want to test Pressbooks out, you can create a sandbox book. Complete the steps below to create a Pressbook from scratch.

- 1. Click on "Create a New Book".
- 2. Create your URL: the URL for all your resources will start with ecampusontario.pressbooks.pub/, and you'll be asked to fill in the remainder. Choose wisely because you won't be able to change it later. For this Activity, call it "My Sandbox". Add a title we suggest "My Sandbox".
- 3. Choose the language of the book (this corresponds to the language of the reader's interface).
- 4. Set Privacy: Choose "No" for this purpose as you don't want your "My Sandbox" book to be visible to anyone but you.

Project Design Considerations - Questions

Before adapting or authoring a book, it's important to establish a plan that will guide the style and design of the new work. The following questions will help to outline the specific characteristics of your book. Each question includes a link to a section in this guide for more information

Design Questions

- 1. What is the **name** of your new resource?
- 2. What Pressbooks Theme would you like for your book?
- 3. How will your content be <u>structured</u> in Pressbooks? See Development Plan
- 4. What pedagogical elements do you want to open and close your chapters?
- 5. Which citation style will you use?
- 6. How do you want to handle key terms?
- 7. What colour scheme do you want to use in your book?
- 8. How do you want to use text boxes?
- 9. Do you want to include any media in your book?
- 10. Do you want to include any **H5P interactives** in your book?
- 11. Do you want any ancillary resources included



- In general, Canadian spellings should be used. Consult <u>Canadian Spelling</u> for first-choice spelling preferences. List any exceptions in your **Style Guide**.
- Boldface is reserved for key terms within the text body, not for emphasis.
- Italics are for words used as words (e.g., The term *vocal cords* is often misspelled. What do you mean by *nexus*?)
- · Words that are meant to alert the reader that a term or word is used in nonstandard, ironic, or

- other special sense should be marked off with quotation marks (e.g., "Child protection" sometimes fails to protect).
- · Words that are common expressions and figures of speech should NOT be set off in any way (and in this text, sometimes they are).

Pressbooks Themes

Themes are the base of the design for your book. Pressbooks offers 20 different themes, tailor-made to suit a wide array of specific genres. For instance, if you're creating a textbook, you may want to choose Jacobs or Andreessen — themes with a more minimalist design, sans serif fonts, and other qualities typically found in educational texts. However, if you're publishing a romance novel, you might choose Bronte or Christie, which are more decoratively designed. Your choice of theme should be one of the first decisions you make when you start creating your book in Pressbooks.

The elements directly impacted by your choice of theme include but are not limited to:


- · Chapter title designs
- · Running content
- Fonts
- · Heading styles
- Pullquotes
- Textboxes
- · Blockquotes
- · Title page layout
- · Copyright page layout
- · Table of contents layout

The theme you choose sets the tone of the design for the entire book and will apply to every supported file format you choose to publish, including EPUB, MOBI, PDF, and webbook. The design will look as similar as possible across all formats. When you first create a book, a theme will already have been applied to the book. For most networks, the default theme is McLuhan.

Before activating a theme, you may want to know more about it. You can hover over any theme on the Themes page and click the Theme Details button to see more information about the theme. This will include details about the theme, the version number of the theme installed on your network, and any tags that have been used to categorize the type of publications the theme was designed for.

Themes are tagged with one or more of the following searchable attributes:

- Academic
- Literary
- Nonfiction
- Textbook
- Genre fiction


Book Structure and Headings

Authors and collaborators often start a project by determining a textbook's structure, or a consistent way to organize content. The textbook structure may take a variety of forms depending on the course content, learning context, pedagogical approach, and other factors.

Below are three typical textbook structures:

- 1. Example 1: Book & Chapter & Section
- 2. Example 2: Book & Chapter & Section & Subsection
- 3. Example 3: Book & Unit & Chapter & Section & Sub-section

For our example, let's say an author decides to organize their book according to example 1, i.e. Book&Chapter&Section. The book structure would look something like this (showing chapter one sections only):



Often a book's structure is described using terms like "parts" or "levels". It may be useful to map the book's structure, thereby creating a basic outline, before beginning to write.

Pressbooks provide Parts and Chapters as a way to structure your book. Parts are the containers for the chapter content, and Chapters contain the content.

Read more - Creating Parts and Chapters

Headings

Pressbooks provides a variety of heading levels beginning with Heading 1 (the most prominent and largest) down to Heading 6.

- 1. The default setting in Pressbooks defines the chapter title as H1, therefore all subsequent headings within a chapter should begin with H2.
- 2. Create a hierarchy for the sections in your chapters and note which headings you've assigned to each in your Style Sheet.
- 3. Decide how words in headings will be capitalized and record this decision in your Style Sheet as well.

Headings are important for accessibility, which we will explore more in the Accessibility Toolkit.

Pedagogical Elements

Now that we have considered common textbook structures, we can look at the pedagogical elements often used in textbook design. These elements are designed to provide context, overview, motivation, review, and other useful functions for learning. They are usually found within chapters or sections. They can be organized into three categories: 1) openers, 2) closers, and 3) integrated pedagogical devices.1

Openers

Openers are pedagogical elements that come before the main content. Their role is to lead the learner into the content and provide motivation or a preview. For example:

Examples

- · Learning objectives (LOs)
- · Introduction/Overview paragraph(s)
- · Focus questions
- · Thought-provoking quote/Image
- · Short case study or example

Closers

Closers are pedagogical elements that come after the main content. Their role is to help learners review or reinforce their learning. Closers aim to help students summarize, review, or practice what they have learned. Example include:

Examples

· Key takeaway statements

- · Key terms list
- · Review questions
- · A section/chapter summary
- · Self-assessment
- · Audio/visual interactive element

Integrated Pedagogical Devices

Integrated pedagogical devices are elements incorporated into the main content. For example, each chapter in a mathematics textbook might include:

Examples

- a "Biography" element that highlights the biography and accomplishments of a famous mathematician.
- \cdot a "Case Study" element that illustrates the concepts by describing a real-world application.
- · vocabulary words in bold.
- · illustration of geometric figures or graphs.

Often, these pedagogical elements are highlighted through design. For example, biographies may always appear inside a text box, accompanied by a photo. This visually distinguishes the pedagogical elements from the other content and makes the element recognizable through consistent use in each chapter, section, etc.

Reference Citation Style

Before beginning writing, it is important to determine the reference citation style. References can be listed at the end of each chapter, at the end of the book, or as footnotes. Note how in-text citations are used including punctuation. Authors are responsible for adding in any references used in APA format, and properly citing work used.

It is important to keep track of all copyrighted works that are used in your writing. A reference management tool can be helpful.

The college's faculty librarians offer research and citation help. For urgent citation help, faculty can drop by the library or reach out through Live Chat 8 a.m. to 8 p.m. weekdays and 11 a.m. to 5 p.m. on weekends.

Citation vs. Attribution

Even though they share characteristics, citations, and attributions play different roles and appear in different places. A strong textbook will show the reader where information and ideas that do not originate with the open textbook author come from. This should be done for both restricted and open works through citations and attribution statements.

Use this as an opportunity to show students by example how a scholar respects and shares information from other sources.

Citation

A citation allows authors to provide the source of any quotations, ideas, and information that they include in their own work based on the copyrighted works of other authors. Excluding resource citations in your own work places you at risk of plagiarizing. Plagiarizing is the act of passing another individual's ideas or work as your own.

Citation is a common and long-time practice among scholars used to indicate where a resource is from and who the author is. Unlike an attribution, citation is typically used for copyrighted works with restricted rights or "all rights reserved." In other words, it is used in works for which broad permissions have not been granted.

As a scholar and potential author of an open textbook, we assume that you are familiar with the rules around citation. However, the article Warning: When You Must Cite from the Yale Center for Teaching and Learning provides some guidance about how, what, and the amount of work that can be cited. Attribution

Attribution is the cornerstone condition when using a resource or text released with an open-copyright license. This legal requirement states that users must attribute — give credit — to the creator of the work.

An attribution statement is used to provide credit to the original creator; its purpose is similar to a citation. Best practice says that the statement should include the title of the work, name of the creator, and license type (with links to each). When using text from another open educational resource, be clear in your attribution statement what section of your textbook contains this information.

Differences

Citation and attribution serve different purposes. The following table summarizes the differences between citations and attributions.

Attributions

When writing an OER, most authors rely on openly available content as a starting point. It is essential when building your OER that you keep track of all the resources used (those that are copyrighted and those that are open). Using the <u>Project Development Plan</u> can be helpful, or you can keep a list in Word or Google, or list the resources on each page in Pressbooks.



NOTE: The attributions should be as close to the content used as possible, therefore the preference is to attribute on each page/section. Record the changes made to the adapted content. In Canadian English, the words license and licence are both used: license (verb), and licence (noun).

For example, this work is licensed under a CC BY 4.0 licence.

Text Attribution Instructions

All text attributions need to be in one of the following forms:

- 1. Title of Work (w/ hyperlink to work) byAuthor Name (w/ hyperlink to author) is licensed under a Licence Name (w/ hyperlink to licence).
- 2. "Title of Section (w/ hyperlink to section page)" in Title of Work (w/ hyperlink to work) by Author Name (w/ hyperlink to author page) is licensed under a Licence Name (w/ hyperlink to licence).

Where the bolded terms are to be replaced with their corresponding information. The choice of the above format is based on the nature of the attribution at hand. If you are referring the reader to the entirety of a work, then #1 should be used. This will often be the case on the OER's Acknowledgements page. However, if you are only referencing a particular section of a work, then #2 should be followed so that the reader knows exactly where the content and information come from.

Text Attribution Examples

<u>Principles of Management</u> by the <u>University of Minnesota</u> is licensed under a <u>Creative Commons</u> <u>Attribution-NonCommercial-ShareAlike 4.0 International Licence</u>, except where otherwise noted.

By contrast, <u>Section 1.3</u> of the same book contains the following attribution:

"Who Are Managers?" in <u>Principles of Management</u> by the <u>University of Minnesota</u> is licensed under a <u>Creative Commons Attribution-NonCommercial-ShareAlike 4.0 International Licence</u>, except where otherwise noted.

Where multiple sections from the same work are reproduced in a single section of the OER you are working on:

"5.1 Price Elasticity of Demand and Price Elasticity of Supply" and "5.2 Polar Cases of Elasticity and Constant Elasticity" in Principles of Economics 2e by OpenStax are licensed under Creative Commons Attribution 4.0 International Licence.

AttributionBuilder

AttributionBuilder composes a standard attribution string for an online OER (Open Education Resource) and is primarily geared toward those resources available on the Pressbooks platform or through OpenStax. A downloadable standalone version and an online version are available.

Example:

AttributionBuilder will provide the code that will display like this:

"Open Initiative at Fanshawe College" from <u>The Journey to Open</u> by Fanshawe College is licensed under a <u>Creative Commons Attribution-NonCommercial-ShareAlike 4.0 International License</u>, except where otherwise noted.

Image Attribution Instructions

All images require attribution in the following form: "Image Name (w/ hyperlink to image)" by Author Name (w/ hyperlink to author page), Licence Abbreviation/Name (w/ hyperlink to licence).

Where the bolded terms are to be replaced with their corresponding information, note that for images, an abbreviation of the licence name may be used. However, these abbreviations should be recognizable to readers outside of the Studio.

Keep in mind that <u>Pixabay</u>, <u>Unsplash</u>, and other online image repositories may have their own licences that are different from the Creative Commons licences. Nonetheless, the above format for attribution should still be followed for images from these sources.

Image Attribution Examples

Note that although this photo does not have a title, we still include a hyperlink to its source, using a placeholder name that describes the media type. Here, the placeholder Photo is used. Other examples of media could include graphic, image, figure, graph, table, animation, etc.

This image has a title, so it is included in the attribution. If the title of the image is long, it can be shortened. Ideally, no longer than 10 words. Also, because the CCO 1.0 Universal license has a common abbreviation as CCO 1.0, it may be used here.


CAUTION

If you are linking to a source of an image where the URL ends in an image file (i.e. .jpg) you will need to add in the code a # or? at the end of the URL or the source, the link will not display correctly in Pressbooks when the lightbox feature is turned on in the book's theme appearance settings.

For example, links to resources on Wikimedia Commons by default end in the name of the image file.

Attributions for Image Adaptations

Adaptations must include a note about what was changed in the image.

Images Used with Permission

Sometimes, OERs will include content that does not have an open license attached to it, but which we may nonetheless use because we have arranged a closed license with the copyright holder to include it in the resource. To indicate this, it is essential to mark reproduced for non-commercial purposes. the rightsholder as well as include the phrase "used

with permission. All Rights Reserved" in the place where the license would usually be marked. The format for this is as follows:

"Title of Image (w/ hyperlink to source)" by Author (w/ hyperlink to author page), © Rightsholder Name (w/ hyperlink to rightsholder page), used with permission. All Rights Reserved.

As an example, see the below where an image from a London business was included in the OER:

In the example above, the hyperlinks and the author have been omitted where that information is unavailable. Images Used without Permission – Fair Dealing

It may be difficult to obtain permission for all materials that you would like to include in your OER. In these circumstances, fair dealing may apply if sharing the image will not impact the rightsholder too negatively. Attributions for material used under the fair dealing provision follow the same format as those with permission, except for a notice that tells the reader the material has been used under fair dealing for educational purposes. The format for this is as follows:

"Title of Image (w/ hyperlink to source)" by Author (w/ hyperlink to author page), © Rightsholder Name (w/ hyperlink to rightsholder page), used under fair dealing for educational purposes. All Right Reserved.



Image Metadata in Pressbooks Media Library

When adding images to the Pressbooks Media Library, metadata should be provided. To ensure that the textbook meets accessibility standards it is especially important to include meaningful alternative text for the

Key Terms and Glossary

Key terms are the "means of exchange" in disciplines. You gain entry into the discussion by demonstrating how well you know and understand them.

A glossary is a list of key terms in a book that are listed alphabetically.

There are two different approaches to creating and emphasizing key terms in your book in Pressbooks.

- 1. Use the Glossary feature that allows the **key terms** to have a hover-over feature.
- 2. Bold the key terms in the content and add a list of the terms and definitions elsewhere in the book.

Approach 1: Glossary Feature (Tooltip Hover)

In Pressbooks, there is an option to add a glossary feature to each word in the content so that a tooltip appears with the definition. For these words, Pressbooks will also compile a list of all words in a glossary in the back matter of the book.

Definitions

Discipline-specific language and any language outside the standard vocabulary of a student audience should be defined in context within the sentence or written in more straightforward language. These terms do not receive special typographic treatment unless considered a key term. Authors should use best practices in defining terms. In brief, best practice recommends the following:

- · Avoid defining a term with a variation of the term itself. For example, "conflict theory is a theory that states society is in perpetual conflict" -> "conflict theory is a sociological framework that explores the tensions that arise from competition for resources."
- · Use nouns to define nouns and verbs to define verbs.
- · Provide a three-part definition (the term, the classification of the term, and the definition characteristics of the term).
 - · For example, "Power: The ability of an individual, group, or institution to influence or exercise control over other people and achieve their goals despite possible opposition or resistance."
- · Use simple and familiar terms.
 - For example, "Member: An individual that belongs to a group."

Using your own words to define your key terms is best, but if you choose to use openly licensed content for a definition, you will need an attribution.

Colours

Colour is an important design choice in your project. Colour can convey meaning and assist with the framework for the project. However, it is important to consider colour contrast. When documents or web pages do not provide enough contrast between foreground elements (e.g., text, images) and background elements (e.g., colour, watermark images), some students will have difficulty reading the content.

Web Content Accessibility Guidelines (WCAG 2.0) require that for level AA, "the visual presentation of text and images of text has a contrast ratio of at least 4.5 except for the following: Large-scale text and images of large-scale text have a contrast ratio of at least 3:1." The image below presents four different foreground/background colour-contrast examples to illustrate insufficient and sufficient colour-contrast ratios.

Pressbooks theme: It's important to note that within the Pressbooks platform, the default templates used to display your core content (text size and font) will conform to <u>WCAG 2.0 level AAA</u>, as demonstrated in the last image below:

In addition, because Pressbooks is web-based, resizing text is possible. "Except for captions and images of text, text can be resized up to 200 percent without assistive technology and without loss of content or functionality (Level AA)."

However, you should not rely on colour as the sole means of conveying information. If the point you are making depends on colour to be understood, you will need to edit your materials so that concepts presented in the visuals are not lost to those who are colour-blind or who require high contrast between colours. ³

Textboxes & Custom Headers

The Pressbooks textbox tool in the visual editor allows you to place text with frames to have it stand apart from the rest of the text in the body of your book. The structure and colour of textboxes may vary from theme to theme.

Pressbooks include six preset textbox styles. Each of these also features a 'sidebar' variation, which will display at 25% of the container width by default and was defined for PDF exports.

To add an empty textbox to your post from the visual editor, click on the Textboxes dropdown and select your desired textbox type. If you do this with a selected text already highlighted, this text will be placed within the newly created textbox.



Ancillary Resources

Open textbook authors should consider adding ancillary resources to their textbook whenever possible. Traditional textbooks often provide instructors with ancillary resources like slides, test banks, image banks and videos.



A BC Faculty Survey on Open Educational Resources found that 12% of faculty wouldn't adopt an open textbook that was not accompanied by ancillary resources, and 28% reported that they felt they didn't have the time to experiment with OER in their classroom.

Adding features that will make it easier for instructors to integrate your book into their teaching will increase the likelihood that it will be adopted or adapted. Ancillary resources that can be created with the help of the OER Design Studio are:

- · Slide decks
- · Instructors guide
- · Chapter summaries
- H5P formative assessment tools

Slide Decks

Slide decks are created using Microsoft 365 and then downloaded and checked for accessibility before being loaded to the back matter of the book. The Studio uses a standard template for slide decks. The slide decks created are basic and take into consideration the learning outcomes and key points of the chapter. Faculty are able to customize the decks to suit their needs.

Instructors Guide

An instructor's guide can be developed to include ideas for in-class activities, or assessments. The Studio can assist in collating additional resources to be included in the instructor's guide.

Chapter Summaries

The Studio can create quick chapter summaries to be added to the end of each chapter. The summaries created will need to be reviewed by the book's author.

H₅P

The Studio will create H5P interactives based on content provided by the book's author or other faculty. See the <u>H5P: Enhancing Interactivity in Pressbooks</u> section in this book for more information.



The author or other faculty can create test banks for the book. The Studio does not create test bank questions. However, the Studio can provide step-by-step instructions on leveraging technology to create and use test banks.

Media Resources

Media resources refer to all items other than text, such as photos, graphs, diagrams, and multimedia content (video or audio links). Decide what media resources you want to include in your book and where. It is essential that all media resources carry an open license or are in the public domain.

Media Considerations

Consider the following as well:

- Resources should have a caption (e.g., Figure 1 + description). See this <u>Resource: Captions and</u>
 Attributions
- Differentiate between figures and tables (e.g., Figure 1.2 or Table 1.2).
- For adaptations, use the numbering system employed by the original author. Use a numbering system for new creations that incorporates the chapter number and image sequence. For example, for the first figure in Chapter 1 caption the figure, Figure 1.1.
- If you want graphs created, you MUST provide the data for the graph. If you need support searching for data, please contact your <u>faculty librarian</u>.

Photos & Graphics

Many open-source photos and graphics are available online to use in your OER. Use the suggestions below to find open-source images and photos.

Using and Finding Open-Source Images

There are many places to find free and open images. However, some images may require us to give credit to the creator or may not allow us to use them for commercial purposes. If unsure about the

rules, please contact the Studio or the Copyright Officer to verify. Review the <u>attributions</u> section to make sure you are meeting the attribution requirements.

- · <u>Unsplash</u>: Offers a vast collection of high-quality, royalty-free images.
- · Pixabay: Provides free images, illustrations, vector graphics, and videos.
- · Pexels: Offers a wide range of free stock photos and videos.
- · Freepik: Provides free and premium graphics, including images, vectors, and PSD files.
- · Wikimedia Commons: A database of freely usable media files, including images.
- <u>Flickr</u>: Search for images using the "Creative Commons" licence to ensure you find content that can be reused and modified under an open-source licence.
- **Icons**: Check out the appendices on Visual Identity in this guide for standard and custom icon sets that can be re-used.

Optimal Image Resolution, Colour Space, and Formats for OER Images and Graphics

When creating images and graphics, or sourcing existing images, it's essential to consider the proper image resolution, colour space, and formats. We can ensure our OER images and graphics are visually appealing and optimized for their intended use.

- 72 to 150 DPI Modern displays use higher pixel density more often, so greater than 72dpi is permissible.
- · RGB Colour Space
- · Minimum 1200 pixels wide

- · Photos: JPEG Exported as medium to high quality, depending on the photo and the resulting file size.
- · Illustrations or other graphics: PNG Transparent background depending on the graphic.
- · Cover Photos: Images should be in Portrait orientation. High-quality, large images are ideal.

Videos

Video resources can provide an alternative delivery of content to students and end-users while providing opportunities to share different contexts and perspectives. Videos are available in the digital format of the book only.

Finding VIdeo Resources

- · YouTube: YouTube authors can license their videos for reuse. Use the filters available to locate Creative Commons-licensed videos. See this Open Washington tutorial on finding YouTube videos with Creative Commons licenses.
- · <u>Vimeo:</u> Vimeo, like YouTube, is a video-sharing site. Search filters allow users to find Creative Commons-licensed videos.
- · TED: All TED content are covered by the Creative Commons license, Attribution-NonCommercial -NonDerivative (BY-NC-ND)

Clarity & Readability	 Is the content, including any instructions, exercises, or supplemental material, clear and comprehensible to students? Is the content well-categorized in terms of logic, sequencing, and flow? Is the content consistent with its language and key terms and provides adequate context for any jargon/technical terminology used?
Accuracy	 Is the content, including diagrams and other supplementary material accurate, error-free, and unbiased? Are there any factual, grammatical, or typographical errors? Are there broken links or obsolete formats?
Adaptability & Longevity	 Is the resource up-to-date, but not in a way that will quickly make the text obsolete within a short period? Does the resource provide an appropriate context for Canadianization (Ontario or Canadian content and examples)? 
Review Process

Once the review is complete, you are encouraged to also complete the review form. If you would like to be mentioned in the textbook as a reviewer, provide your information in the form.



The Power of Metadata

Metadata is data that provides information about other data. When you share OER through any repositories, you will be asked to provide information such as the title, author name, type of material, keywords and tags. This metadata becomes associated with that material — and facilitates the search process. Additionally, when you provide information about others' OER — by rating, reviewing and tagging the material — you give metadata that becomes attached to that OER. The metadata you provide in your own OER — as well as the information you provide by tagging, rating and reviewing others' OER — enriches the content by giving descriptive information that assists in searching and re-using the materials. The more complete and descriptive the metadata is, the more discoverable the work will be.

Distribute

Once you've completed your new open textbook, you must decide how to share your work with your students, your colleagues, the bookstore and library at your institution, and the general public.

File Types

Students like flexibility when it comes to their textbooks. Some may prefer printed versions of the textbook, others prefer using a website, and some may prefer reading using an e-reader or tablet. To make your book as accessible as possible, consider making your textbook available in multiple formats so students have the ability to choose the format that works for them. Remember to include editable files so that others can use your work to create their own adaptations. Pressbooks will allow you to export your book in a variety of file types, both editable (.xml, .odt, .html, .epub) and less editable (.pdf and .mobi) files.

H5P: What, Why, and When

H5P is a free, open-source tool that allows users to create web-based interactive learning activities. It is a plugin that allows users to create interactive content in an existing authoring platform (WordPress, Pressbooks or through an LTI with a Learning Management System- FOL). H5P stands for HTML5 Package, the latest version of the standard markup language used to structure and present content on the web.



The best way to learn about H5P is to explore the many content types. The following section provides examples of the different content types available. It is essential not to use it just because it exists - but to consider how it will serve you in your teaching and learning context.

Why create H5P?

There are some powerful reasons to create H5P for Pressbooks:

- · Help students achieve chapter learning objectives. Each interactive will deepen a student's understanding of the key terms, skills, or concepts that guide the chapter.
- · Give students more opportunities to check comprehension. Learner interaction, discovery, and agency allow students to shift from passive to active learners. Interactives in the text reinforce and interleave content, supporting new learning pathways.
- · Increase the relevance and overall appeal of the Pressbook. Future educators and adopters look for built-in student interaction.

When to Use H5P

Everyone's teaching and learning contexts are different - but one aspect that rings true for all is we don't want to overcomplicate or introduce elements when they don't have a purpose. When considering using H5P for your course or resource, evaluate whether it supports the following key principles:

- 1. The H5P aligns with the intended learning outcomes
- 2. The H5P provides an opportunity to incorporate multimedia (multiple modes) to help manage cognitive load during learning.

3. The H5P allows learners to engage with the content – supporting active learning.





Flashcards

The Flashcards content type is a set of cards containing a picture on one side of the card and a corresponding text on the other side. The learner is asked to type a word or expression corresponding to the picture, before turning the card over and revealing the correct answer.

The Multiple Choice content type is your staple multiple choice quizzing tool. Multiple Choice can be used to test the learner's level of knowledge on a given topic.

The speech engine used is currently only available in the Chrome browser.


H5P: Finding Existing Content




Sharing is an action (or verb). It can be defined simply as giving something to another. Sharing can be a one-way transaction, and it happens when the item or resource is complete.


